## **CANCELLATION, REFUND AND NO-SHOW POLICY**

- Substitutions cannot be made after **Friday, October 9, 2026**.
- There will be no refunds or credits for cancellations after **Friday, October 9, 2026**.
- All cancellation requests must be in writing and can be emailed or sent to IEDC.
- All registered attendees canceling their registration will be charged a \$130 processing fee, regardless of when the written cancellation notice was received.
- Cancellation requests received by IEDC prior to the close of business on **Friday, October 9, 2026**, will have their registration fees refunded or credited to a future IEDC event, less the \$130 processing fee.
